Credit cards will be accepted at our office 24 hours prior to contract date. **OVERTIME** must be paid in **CASH ONLY!** If cancellation occurs within 30 days of this contract date, you are responsible for the full balance. Contractee is responsible for any damage caused to vehicle by themselves or parties he/she allows into vehicle. Broken/missing glasses will be charged a fee of \$15.00 per glass. **NO DRUGS OR SMOKING** shall be allowed in any vehicle. All passengers must be 21 years of age or older for ALCOHOL to be permitted in the vehicle. If you spill any kind of fluid, food or vomit in the vehicle you will be charged a \$150.00 sanitation charge. Standing through the sunroof, hanging out of windows or throwing debris from the vehicle is strictly prohibited!
